President The president presides over meetings of the organization and executive board, serves as the primary contact for the principal, represents the organization at meetings outside the organization, and coordinates the work of the officers and committees. Although this is a one-year term, the following year the "past president" will remain on the board in an advisory capacity to the following president and Executive Board. {4+ hours per week}

Vice President The vice president serves as an ex officio member of all committees (except the nominating committee). The vice president is also oversees and maintains an inventory of all PTO property. In addition, the VP assists the President and carries out the president's duties in his or her absence or inability to serve and other duties as may be assigned. {2-4 hours per week}

Secretary The secretary keeps digital and paper records of the organization, takes minutes during meetings, handles correspondence, and sends notices of meetings to the membership. The secretary

also keeps a permanent copy of the minutes, bylaws, procedures, membership list, and any other necessary supplies and brings them to meetings. {1+ hour per week}

TreaSurer The treasurer is responsible for the funds of the organization; keeping an accurate record of receipts expenditures, and pays out funds in accordance with the approval of the executive board. The treasurer provides a financial statement at every meeting and at other times of the year when requested by the executive board or general membership, and makes a full report at the end of the year. The treasurer also ensures all PTO activity is in compliance with current Internal Revenue Service (IRS) and state requirements. {4+ hours per week}

Parliamentarian The parliamentarian ensures that "Robert's Rules of Order" are being utilized at meetings. The parliamentarian also takes the lead to establish, update, and maintain the organization's policies, guidelines, and bylaws. {1+ hour per week}
